## BUSHFIRE SCIENCE INTERACTION IN STAWELL

It's been raining, it's been pouring but what does this mean for bushfire risk and your preparations for the next fire season?

An expert panel of bushfire researchers discussed bushfire behaviour, risk, and how to best communicate information at the Stawell Entertainment Centre in western Victoria in May.

The audience interacted with the speakers by voting on hand-held key pads (see photo, right) to various questions raised during the presentations. The public event was put on by Free Range Science and hosted by RiAus (The Royal Institution of Australia) as part of its Talking Science in Regional Victoria program.

This Bushfire Science event was supported by the Bushfire CRC with several researchers contributing to the program. Two Bushfire CRC speakers headed up the program at Stawell, Researcher Dr Chris Weston, of the University of Melbourne, spoke about the role of fire in the landscape with specific references to the



history of fire and the changing vegetation in this part of Victoria. John Schauble, Acting Commissioner in the Office of the Emergency

Services Commissioner, talked about research conducted on how communities make a decision on whether to stay and defend their households or leave early. John is a lead end user in the Bushfire CRC program Effective Communication - Communities and Bushfire. Michael Boatman, CFA manager of community safety for the Grampians region, showed how the research was being applied by partners in the Bushfire CRC, in particular, how the CFA was informed by research conduced on community attitudes and decision making processes.

## A MODEL RESPONSE TO THE ROYAL COMMISSION

A report detailing the Victorian Government's progress on implementing the 67 Bushfires Royal Commission recommendations was tabled in State Parliament this week.

Tabled by the Deputy Premier and Minister for Bushfire Response, Peter Ryan, the Bushfires Implementation Plan outlined the measures being taken by the Government to improve Victoria's response to future bushfires.

Of specific interest to the Bushfire CRC is the progress on recommendation number 65 – that the Commonwealth establish a national centre for bushfire research. Although this recommendation is directed at the Commonwealth, the Victorian Government is in full support and keen to make this a reality.

The report notes that the Bushfire CRC has a proposed model for an Australasian Fire Research Institute. It is pleasing to read that the Victorian Government will progress this model with the Commonwealth this year via the National Emergency Management Committee.

### RESEARCH PROMINENCE AT WILDFIRE CONFERENCE

The Bushfire CRC was represented at the Fifth International Wildfire Conference in South Africa in May by the Chairman, CEO and several researchers. It was clear from the open discussions on the potential for collaborative research that Australian and New Zealand bushfire science has much to learn and much to offer with international colleagues in this field. Bushfire CRC researchers who presented

included Mick Meyer, Jim Gould, Fabienne Reisen and Raphaele Blanchi, all from CSIRO. Neil Burrows presented for researcher Roy Wittkuhn (both WA DEC), Alen Slijepcevic presented for Andy Ackland (both DSE Vic) on practical use of Kevin Tolhurst's research and presentations were also heard from Bushfire CRC Board members Murray Dudfield (NZ National Rural Fire Authority), Naomi Brown

(AFAC) and Ewan Waller (DSE).

All up, the Bushfire CRC was prominent throughout the conference in 20 sessions by people proudly acknowledging their involvement in the Bushfire CRC and its research.

The Bushfire CRC coordinated a prominent poster display on the Australasian Wildland Fire Network, which showed the links between the Bushfire CRC, AFAC, NAFC, FFMG and PIFSA.

### RESEARCH BLOG RICHARD THORNTON



Around 60 end-users, researchers and students gathered at the Oueensland

Fire and Rescue Service's complex in Kedron Park, Brisbane for the fourth meeting of the Research Advisory Forum (RAF). The audience heard progress reports and presentations from around half of the projects in the Bushfire CRC and from a number of students. It was particularly pleasing to hear that all of the projects are now underway and are making substantial progress. We heard from researchers and students who are conducting research in all states and New Zealand.

The feedback from the forum was highly positive with most attendees rating it very highly; also the general feedback on the projects was equally positive. Many of the researchers received approaches from the end-users to work in their jurisdiction and be involved with the research.

The RAF is a critical part of the research governance for the Bushfire CRC and the feedback from the stakeholders has been compiled and will be discussed with the individual projects and lead end-users in the coming weeks.

The next meeting will be held in Canberra on the 26-27 October, and the presentations from the forum will soon be available under the events tab of the website.

#### RESEARCH UTILISATION BLOG **NOREEN KRUSEL**

#### RESEARCH BLOG MICHAEL EBURN



Last month, with the support of the Bushfire CRC, I had the chance to travel to San Diego to take part in the 5th Annual Wildland Fire Litigation conference to share insights into Australian law and to learn about the conduct of post-fire

litigation in the United States. The conference has a unique format. The organisers realised that there was a reasonably small cohort of lawyers conducting fire cases so it aims to bring lawyers from all sides to the table to learn from each other and to work together to actually limit the issues that are disputed before the court.

As part of the Bushfire CRC research on mainstreaming emergency management across law and policy, I gave a paper on the 'state of play' of bushfire litigation in Australia and identified some issues that may explain why we have much less post fire litigation than our American colleagues. I was also able to represent the Bushfire CRC at the sponsor's hall and there was significant interest in the CRC research program, and collecting copies of Fire Australia.
